MEETING PURPOSE

SOLICIT INPUT ON THE SCOPE OF THE EIR

- Bay Area Toll Authority (BATA) and Caltrans are preparing an environmental impact report/ environmental assessment (EIR/EA) to identify potential impacts of the Gateway Park project.
- A Notice of Preparation (NOP) is sent to agencies and interested parties to solicit participation in determining the "scope" of an EIR.
- Scoping helps identify environmental issues of concern and potential alternatives.
- This scoping meeting provides another opportunity for obtaining this information.
- The scoping period is November 1 to December 6. Responses are due to BATA by Friday, December 6.






PURPOSE AND NEED

The primary purpose of the proposed project is to provide a distinctive entryway park to the East Bay that connects to the bicycle/pedestrian path on the new East Span of the Bay Bridge.

The project will also provide safe multi-modal access to the shoreline and passive and active recreation opportunities. The project purpose also includes providing interpretive features for natural resources and transportation history, and a venue for community events and art installations. It will be designed to meet mitigation commitments for a number of transportation projects, including the new East Span of the Bay Bridge.







PROJECT OBJECTIVES

TRANSPORTATION AND SHORELINE ACCESS OBJECTIVES

- Provide public shoreline access connecting to West Oakland, the City of Oakland, the East Bay and the growing urban population at large.
- Facilitate multi-modal connections to the shoreline and regional park (bicycle, pedestrian, transit, auto and water craft).
- Provide improved staging and access to the bicycle and pedestrian path on the new East Span of the Bay Bridge.
- Provide links to existing and planned segments of the San Francisco Bay Trail. When eventually completed, the linear Bay Trail will be a continuous, 500-mile bicycle/pedestrian trail encircling the entire Bay Area.







PROJECT OBJECTIVES


REGIONAL PARK AND RECREATION OBJECTIVES

- Create a distinctive entryway park that reflects the people, history and culture of the East Bay.
- Provide a destination for residents and visitors to view and access San Francisco Bay and the new East Span of the Bay Bridge, as well as view the Port of Oakland operations.
- Provide active and passive recreation opportunities, including walking, nature appreciation, interpretation of transportation history, bicycling, fishing, and non-motorized boating.
- Provide opportunities for the interpretation of San Francisco Bay natural resources, transportation history, and the history of the Port of Oakland.

- Provide a venue for community, regional, and national events.
- Provide a venue for art installations.
- Provide a learning environment for students to experience San Francisco Bay natural resources and transportation history.
- Provide a long-term sustainable regional park, including revenue generation opportunities for funding park operations and maintenance.
- Provide the required mitigation for other transportation projects.










OVERALL PROJECT CONCEPT







OUTREACH TO-DATE





COMMUNITY INPUT

The Gateway Park Working Group has gathered comments on the 2012 initial design proposal and identified key issues.

THESE INCLUDED:

- Air quality for park users and those biking to and from the park
- Potential conflicts between trucks and bicyclists on Maritime Road
- Integration of the billboards with the park design
- Funding source(s) for all the proposed park elements
- Who will own and operate the park?
- Design park to be inclusive for all types of users

IN RESPONSE TO THESE COMMENTS, THE 2012 PARK PLAN AND DESIGN HAVE BEEN REFINED AS FOLLOWS:

- Replaced active recreation areas with planting near the Toll Plaza and the I-80/580/880 interchange
- Identified a safe bicycle/pedestrian connection to the Grand/Mandela/Peralta corridors
- The billboards are not a part of the park project
- Adopted phased-development approach to promote private and philanthropic participation
- Initiated discussion on long-term park governance
- Improved park access for all transportation modes

OTHER DESIGN REVISIONS INCLUDE:

- Replaced museum with other interpretative features throughout the park
- Added a more direct path through the park to the Bay Bridge
- Developed opportunities for more active-use areas in the park






